e.g. when registering between 11- 19 head, each calf registration will also be \$15.00 each.

• From 1st August 2014, existing active bulls are included in the total herd size, attracting the same fee per head as active females. From 1st January 2024, any **new** calf or steer recording shall attract a fee.

• As of 1st January 2024 registration of progeny born during the inactive period of an animal shall attract **DOUBLE** the registration fee
